**[PROPOSED] ORDER GRANTING
MOTION FOR APPROVAL OF
DISTRIBUTION PLAN**

On August 3, 2009, the above-captioned matter came on regularly for hearing at 10:00 a.m. in Courtroom 1 of the above-captioned court with Debra A. Riley of Allen Matkins Leck Gamble Mallory & Natsis, LLP appearing on behalf of Thomas F. Lennon, the Court-appointed permanent receiver ("Receiver") for LifeClicks, LLC, 12daily Pro, and their subsidiaries and affiliates (collectively, "12DP"), and other parties appearing as reflected on the record.


The Court having considered the Motion for Order Approving Distribution Plan for Distribution, and related pleadings ("Moving Papers") and argument of counsel, and it appearing to the Court that (a) the Court has jurisdiction over this matter, (b) notice was sufficient under the circumstances, (c) the relief requested is

1 in the best interest of the receivership case of 12DP, and (d) the legal and factual
2 bases set forth in the Moving Papers establish just cause for the relief granted
3 herein; and good cause appearing therefor,

4 IT IS HEREBY ORDERED, ADJUDGED AND DECREED as follows:

- 5 1. The Motion is hereby granted;
- 6 2. The Distribution Plan is approved in its entirety;
- 7 3. The Receiver is hereby authorized to take all necessary and appropriate
8 actions to implement the Distribution Plan;
- 9 4. The form of Distribution Agent Agreement attached as Exhibit A to the
10 Lennon Declaration is approved and the Receiver is authorized to make
11 any necessary modifications thereto without further Court approval;
- 12 5. The *de minimus* threshold is approved and all Allowed Claims against
13 the 12DP receivership estate in the amount of \$45.00 or less are
14 disallowed in their entirety;
- 15 6. The October 1, 2009 deadline for all 12DP Investors with Allowed
16 Claims to provide/confirm their current physical address via the
17 Address Web Portal is approved and all Allowed Claims of 12DP
18 Investors that fail to take this action on or before October 1, 2009 are
19 disallowed in their entirety; and
- 20 7. The Distribution Notice attached as Exhibit B to the Lennon
21 Declaration is approved.
